Footnotes: 1) Flow Rates for each product exceeded the limits of the testing apparatus. The flow rate at 50mm water head was determined considering flow measured at head losses between 24mm and 29mm, multiplied by 50mm and dividing by the measured head loss in mm.

2) Products FL-04401E and FL-04580E were evaluated by stitching together and gluing narrow strips of fabric to produce a fabric of sufficient width to fit the 200mm diameter specimen holder.

All fabric testing was undertaken by a reputable 3rd party testing facility. The values provided are considered by the manufacturer to be true and accurate at the time of manufacture and shipment to the original purchaser.
